Kate Mullin Association – Chairperson's Report for 2022

Scholarships

We decided to change from 4 to 1 year scholarships to reduce our risk into the future.

In 2022 we signed agreements with Curtin and Central Queensland Universities.

We completed a separate agreement with Curtin University for their On-Country program (OCTE).

The two winners of the Curtin On-Country Scholarships were: Shanice Fleming (Broome) and Brianna Taylor-Ellison (Derby).

An addition Curtin student, Kathleen Murphy, was also awarded a scholarship

These are in addition to the ongoing award of a scholarship to Shanae Tesling at CQU in Geraldton.

Our sponsor, ARC Infrastructure, organised for professional photos to be taken of Shanae.

For 2023 we decided to award up to 5 scholarships including 2 to OCTE students.

Educators Award

The KMA received a \$3,000 donation from the Lindsay Cozens Trust for the Award.

Bev recommended moving the process earlier in 2022 with applications closing at the end of week two, Term 3. The selection panel recommended that the winners be required to provide professional learning and to promote the

Award.

The winning application was received from Ed Shaw, Teacher, and Marilyn Daylight Aboriginal Teacher Assistant (ATA), from Purnululu Aboriginal Independent Community School.

The winners were announced at the WATESOL AGM held in November 2022.

Two applications, received from Jacinta Bayliss, EALD Teacher at Broome Senior High School, and Margaret Kungah, Teacher at Kururrungku Catholic Education Centre, were awarded certificates of high commendation.

Fund-Raising

IN 2022 we received \$7,130 from individual supporters and \$6,000 from corporate supporters, totaling \$13,130.

We also received a \$500 donation from the Commonwealth Bank.

We applied for but missed out on a Bennelong Foundation Grant.

No fundraising events were held during 2022.

Logo

The original KMA logo dated from the inception of the Association in 2010 and was in need of review.

Through Niki, Utari Mijayanti, Media and Communications Officer, along with Andrew Beck, Aboriginal Education Consultant at AISWA, agreed to review the logo.

Our main requirements were that the logo reflect our focus on Aboriginal students.

After a couple of iterations, Utari provided two logos from which to choose, and the committee voted 4-3 for "Design 1":



The new logo:

- Keeps the burnt orange from the old logo and removes the bright red.
- Modernises the font.
- Has concentric circles representing the sharing of a specific site, waterhole, or meeting place. This symbol is used to describe the Association as a meeting place for individuals to improve the literacy levels of Aboriginal children.
- Has small circles (on the outer side) symbolising a child, and emphasising the Association's primary purpose.

The new KMA logo is now on the KMA letterhead and on email, website and Facebook banners.

Other

Our Patron, Ken Wyatt, the first Indigenous Australian elected to the Federal House of Representatives, decided to step down following his retirement from politics. We are looking for a new Patron in 2023.

Curtin University produced a video showcasing their OCTE teacher training program. The video included a segment about the Association, which makes it a good item to use in fundraising ventures.

The strategic plan was reviewed this year.
